\_\_\_\_\_ Rented equipment/item(s) must be free of materials, such as food, ribbon, tape, balloons, tablecloths, etc. prior to pick up/delivery, or a cleaning fee will be assessed.

\_\_\_\_\_ Customer understands if the item(s) are lost or returned broken, Customer will be charged for the replacement value of each broken or lost item (**\$200-\$1000** per canopy, **\$50-\$100** per table, and **\$30** per white stackable chair, **\$50** per chivari chair and **\$25** per chivari chair cushion, **\$5** cleaning fee for stained cushion).

\_\_\_\_\_ Customer understands that the item(s) are not to be left outside or left unsecured overnight.

Customer agrees to indemnify and hold MEC Rental, its owners, employees, and agents, harmless from any and all claims, actions, proceedings, costs, expenses, damages and liabilities, including reasonable attorney fees, arising by reason of injury, damage, or death to persons or property in connection with, or resulting from, the use of the equipment, canopies, tables, and/or chairs, including the manufacture, selection, delivery, possession, use, operation, or return of the equipment.

canopies, tables, and/or chairs unless. MEC Rental cannot, under any circumstances, be held liable for injuries as a result of acts of God, nature, or other conditions beyond its control or knowledge. Customer also agrees to indemnify and hold MEC Rental harmless from any loss, damage, theft, or destruction of the equipment during the term of the Agreement and any extension thereof.
